This is a CONTRACT between J D Kennel and the Pet Owner who by signing this contract certifies to the accuracy of all information given about said pet(s) and agrees to all conditions listed below.

1. I, the owner, agree to pay the rate for boarding in effect on the date my pet is checked into the kennel. I am aware that all pets are charged for the date they come in and any day they are here after 11:00 AM, which includes Sundays. Dogs will be bathed, including nails clipped and ears cleaned at owner's expense unless otherwise instructed.
2. Reservations will be accepted, but not guaranteed without a credit card. From November 15 thru November 30 and December 15 thru January 15, a **50 %** deposit is required to guarantee your reservation. If you cancel your reservation at any time during these dates, this deposit will not be refunded. All other holidays, a **\$50.00** deposit will be required. New clients will be required to pay a **\$50.00** deposit for guarantee of first appointment.
3. If you need to cancel your reservation, please do so 48 hours before arrival date to avoid being charged for 1 day of boarding. Cancellation policy does not apply to holiday reservations. Thanksgiving and Christmas reservations must be cancelled by the 15<sup>th</sup> of the month to avoid losing deposit.
4. If my pet becomes ill or the state of my animal's health otherwise requires professional attention, J D KENNEL will attempt to notify me (the owner) first. If I cannot be reached, I authorize the kennel in its sole discretion to engage the services of a veterinarian and I agree to pay for all acquired expenses.
5. We are prepared to care for older pets and to administer routine medications for chronic conditions, but we are not equipped to care for acutely sick pets or aggressive or biting pets. We reserve the right to refuse to accept your pet if at check-in, if it appears to us that your pet is sick or that its behavior could jeopardize the health or safety of other pets or our staff. If you pet is receiving medication, please provide only the amount needed during their stay. We ask that you provide a list of medications and dosage instructions. There is a fee of \$2.00 per time (ex. AM and/or PM) administered.

6. I fully understand that while my pet is being boarded at J D KENNEL, it is my responsibility to make certain my pet is current on all vaccines. Bordetella (kennel cough) must be updated every six (6) months. I also understand that all pets over eight months MUST be spayed or neutered. J D KENNEL will NOT accept any unaltered animals.

7. All fees are due upon release/delivery of my pet unless previously authorized by management. We accept payments of cash, check or credit cards including Visa, MasterCard and American Express.

8. Abandonment: Should the circumstances arise that your pet(s) remain unclaimed for seven (7) day's beyond the agreed check-out date, and we have had no contact with you regarding extending their boarding agreement, the dog(s) will be considered abandoned and J D KENNEL will commence adoption procedures. A certified letter (return receipt requested) will be sent to the address you provided in this agreement. If the pet is not picked up within 7 days from checkout date, the pet will be deemed abandoned, and turned over to animal control or an adoption facility. JD KENNEL will then have no further responsibility for the pet. Such action will not relieve you from paying all costs associated with the boarding and adoption.

9. This written agreement constitutes our entire and only agreement and there are no oral agreements or understandings except as provided for herein. This agreement can only be changed in writing signed by you (the owner) and J D KENNEL. This agreement shall bind us and our assigns and you and your heirs and assigns. The law that applies to the agreement is the law of the state and municipality where your pet is to stay. If there are disputes that result in litigation, the courts of the state and municipality where you pet is to stay shall have exclusive jurisdiction.

10. J D KENNEL will exercise reasonable care for the pet delivered to the kennel for boarding. It is expressly agreed by me (the owner) and J D KENNEL, the kennel's liability shall in no event exceed the value of a pet of the same breed. While your pet is staying with us, he or she will come into contact with other pets, I (the owner) acknowledge and agree that in the unlikely event my pet is injured by another pet, I will not hold J D KENNEL responsible for the injury. If my pet injures another pet, I (the owner) will be solely responsible for any injury. All pets coming into the kennel are fully vaccinated. However, it is still possible for a pet to become ill, even if vaccinated. This is not due to any circumstance or condition at the kennel and I agree that I will not hold J D KENNEL liable in the event my pet becomes ill during or after its stay.

11. We do not accept personal belongings of your pet; this includes toys, beds, blankets, etc. All campers are given blankets and toys.

12. Van service: Pickup and delivery is between 7:00 and 11:00 AM specific time of service cannot be promised. If you have a morning flight please schedule pickup for the day before or you can bring your pets to kennel. If you have someone else meet us, make sure they are there between the hours listed above, if no one is there we will move on and not back track. If you fail to cancel an appointment for our van service, and our van shows up at your residence, you will be charged \$15.00 for our time and fuel used. Anyone using the van service must have a credit card on file.

13. If you want your pet to eat their own food, please send only what they will need for their stay. We prefer zip-lock bags with amount of food that they eat for each meal, no large bags or containers please.

Following these simple rules allows us to spend more time with your precious pets.
