Contract

This is a contract between JD Kennels and the Pet Owner who, by signing this contract, certifies to the accuracy of all information given about your pet(s) and agrees to all conditions outlined below.

1. I, the owner, agree to pay the current rate for boarding (\$44.00/daily for the first dog; \$39.00/daily per additional dog in the same cabin; \$34.00/daily for the first cat; \$29.00/daily per additional cat in the same condo) in effect on the date my pet is checked in to the kennel. I am aware that all pets are charged for the date they check-in and any date they are boarded after 11:00 AM, which includes Saturdays and Sundays. Deposit for each dog is \$50.00.

2. All fees incurred are due upon release/delivery of my (the owner's) pet unless previously authorized by management. JD Kennels accepts payments of cash and/or credit cards including Visa, MasterCard, and American Express. We do not accept checks.

3. Your (the owner's) pet(s) must be people-friendly, as they will need to be cared for by JD Kennels' staff. JD Kennels reserves the right to deny your pet if, at check-in, it appears that your pet is sick or that its behavior could jeopardize the health and safety of other pets or our staff. Additionally, if your unaltered female pet(s) go into their heat cycle, we will need your local emergency contact to come to pick up your pet(s) as this can cause aggression in our other guests.

4. If my (the owner's) pet becomes ill or the state of my animal's health otherwise requires professional attention, JD Kennels will attempt to notify me (the owner) first. If I cannot be reached, I authorize JD Kennels in its sole discretion to engage the services of a veterinarian and I agree to pay for all expenses incurred.

5. JD Kennels is prepared to care for older pets and to administer routine medications for chronic conditions, but we are not equipped to care for acutely sick or aggressive pets. If your pet is receiving medication, please provide only the amount needed during their stay. We ask that you provide a list of medications and dosage instructions. Additionally, we do NOT accept pets within four (4) weeks post-op from major surgeries or procedures (including spays and neuters).

6. I, the owner, fully understand that while my pet is being boarded at JD Kennels, it is my responsibility to make certain my pet is current on all vaccines. Bordetella (prevention of kennel cough) must be updated every 6 months. Kennel Cough is an airborne virus and Bordetella is much like a Flu vaccination for humans, in that it helps to protect your pet from getting certain strains of kennel cough but does not guarantee protection from all strains and it limits the severity of the virus should it be contracted. JD Kennels is not financially responsible for the medical treatment of your pet should they contract kennel cough while at our facility.

7. JD Kennels will exercise reasonable care for the pet(s) delivered to the kennel for boarding. It is expressly agreed by me (the owner) and JD Kennels; the kennel's liability shall in no event exceed the value of a pet of the same breed. While your pet is staying with us, he or she will come in contact with other pets. I, the owner, acknowledge and agree that in the unlikely event my pet is injured by another pet, I will not hold JD Kennels responsible for the injury. If my pet injures another pet, I, the owner, will be solely responsible for any injury. All pets coming into the kennel are fully vaccinated; however, it is still possible for a pet to become ill, even if vaccinated. This is not due to any circumstances or conditions at the kennel, and I agree that I will not hold JD Kennels liable in the event my pet becomes ill during or after its stay.

8. Abandonment: Should the circumstance arise that your (the owner's) pet(s) remain unclaimed for seven (7) days beyond the agreed check-out date and JD Kennels has had no contact with you regarding the extension of their boarding agreement, the pet(s) will be considered abandoned, and JD Kennels will commence adoption procedures or turn the pet(s) over to animal services at their discretion. A certified letter (return receipt requested) will be sent to the address you have provided in this agreement. JD Kennels will then have no further responsibility for the pet. Such action will not relieve you from paying all costs associated with the boarding and adoption.

9. If you (the owner) wish for your pet(s) to eat their own food, please send only what they will need for their stay. JD Kennels prefers individual plastic bags containing the amount of food that each pet will eat for each meal. NO LARGE BAGS OR CONTAINERS, PLEASE.

10. JD Kennels requests that you (the owner) do not bring any personal belongings for your pet(s) besides food and/or medication. Should you insist on doing so, we cannot guarantee its safe return upon check-out.

11. Chauffeur Service: ALL PICKUPS AND DELIVERIES MUST BE A HAND-TO-HAND TRANSFER. Pickups and deliveries are between 7:30 AM and 11:00 AM. Specific times of service cannot be promised. If you (the owner) have a morning deadline, please schedule the chauffeur service for the day prior, or you can bring your pet(s) to our facility in person. If you have someone else scheduled to meet our chauffeur, please ensure they are present between the hours listed above for a hand-to-hand transfer. If no one is there when the chauffeur arrives, he/she will move on and not backtrack. If you fail to cancel an appointment for our chauffeur service and our chauffeur shows up at your residence, you will be charged \$30.00 for the time and fuel used. Anyone using the chauffeur service must have a credit card on file.

12. This written agreement constitutes our entire and only agreement and there are no oral agreements or understandings except as provided for herein. This agreement can only be changed in writing and signed by you (the owner) and JD Kennels. This agreement shall bind us and our assigns and you and your heirs and assigns. The law that applies to the agreement is the law of the state and municipality where your pet is to stay. If there are disputes that result in litigation, the courts of the state and municipality where your pet is to stay shall have exclusive jurisdiction.
